WAIVER OF LIABILITY AND INDEMNITY AGREEMENT "Golf Cart Waiver"				
I, ("Member/Guest"), agree that in consideration of being permitted to use Rowley Country Club's ("Owner") golf cart ("Cart") located at Rowley Country Club do hereby release, waive, discharge and covenant not to sue Owner, its members, officers employees and agents from liability from any and all claims, including the negligence of Owner resulting in personal injury, accidents or illnesses, including death, and property loss arising from use of the Cart.				
Use and control of a golf cart, by its very nature, carries with it certain inherent risks that cannot be eliminated regardless of the care taken to avoid injuries. The specific risks vary from one activity to another, from one location to another, from one individual to another, but the risks of driving, riding or using a golf cart range from minor injuries to major and catastrophic injuries including paralysis and death. I understand and agree that it is my responsibility to assess the hazards presented by my use of said Cart and further agree that I am the ultimate judge as to whether I can use the Cart without risk of harm to myself and others.				
<b>Indemnification and Hold Harmless</b> : I also agree to DEFEND, INDEMNIFY AND HOLD HARMLESS the Owner, its members, officers, employees and agents, from and against any and all claims, demands, actions or causes of actions, for costs, attorney's fees, expenses or damages to personal property, or personal injury, or death, which may result from any use of the Cart.				
The undersigned further expressly agrees that the foregoing waiver is intended to be as broad and inclusive as is permitted by the law of the Commonwealth of Massachusetts and that if any				

portion thereof is held invalid, it is agreed that the balance shall, notwithstanding, continue in full legal force and effect.

Users: I understand and agree those who sign this agreement and hold a valid state Driver's License shall be allowed to operate the Cart. Furthermore, I understand that I must observe all state and local traffic laws.

Acknowledgment of Understanding: I have read this waiver of liability and indemnity agreement, fully understand its terms, and understand that I am giving up substantial rights, including my right to sue the Owner, its members, officers, employees and agents. I also understand that this agreement binds my heirs, executors, personal representatives, attorneys-oflaw, attorneys-in-fact, administrators and assigns, as well as myself. I acknowledge that I am signing the agreement freely and voluntarily, and intend by my signature to be a complete and unconditional release of all liability to the greatest extent allowed by law. I hereby assert that my use of said Cart is voluntary and that I knowingly assume all such risks incident to using said Cart.

FURTHERMORE, I REPRESENT THAT I AM FAMILIAR WITH THE OPERATION AND USE OF SUCH GOLF CART, THAT I HAVE READ THE RULES AND INSTRUCTIONS CONTAINED HEREIN, AND THAT I AM CAPABLE OF OPERATING THE GOLF CART SAFELY AND IN ACCORDANCE WTH SAID RULES AND INSTRUCTIONS.

#### **General Course Policies**

We reserve the right to pair twosomes and singles. Fivesomes are not permitted at any time.

Golfers should be at the course at least 15 minutes prior to their tee times in order to be signed in, warmed up and at the tee on time. We strive to be on time on the first tee all day long.

The expected pace of play is 2 hours for 9 holes and 4 hours 10 minutes for 18 holes. The pace of play will be monitored. Hit from tees that you are most comfortable with, to ensure a well paced round. After hitting, go directly to your ball; Play Ready Golf, ensures faster play for all.

We reserve the right to pair all singles and twosomes as necessary.

Personal coolers and outside alcohol are not permitted anywhere on the premises.

#### **Tee Time Policies**

Members may book tee times one week in advance of play; the general public can book 3 days in advance.

#### **Dress Code**

Acceptable attire will be that which is accepted by the PGA, LPGA AND USGA.

Shorts, skirts and skorts should be of reasonable length.

Please note: If you wear golf shoes with spikes and cannot pick up your feet, please do not wear them as it causes damage to the greens.
